(UMARA) or practice or qualify therefore, and to be conducted on various speedways licensed by and under the sanction of UMARA and promoted by the recognized or accepted promoters for and in consideration of being so permitted to enter upon any one of these speedways and to participate in or be present at automobile and/or other races to be held upon said grounds and for the further consideration of the sum of \$1.00 and other valuable considerations, receipt of which is hereby acknowledged and the waivers, release, discharge and relinquishment and agreements hereby contained does hereby relinquish, give up, forgo, waive, release and discharge said successors, assigns, officers, officials, agents, assistants, representatives, committee and employees and UMARA, it's officers representatives or employees, during the entire calendar year, and at any and every race participated in, in any way, by the undersigned, and from any and all liability claims, demands, and causes of action whatsoever which the undersigned may have, or which may accrue in his favor against them, or any, or either of them, in any way growing out of or resulting from or arising in connection with said races and activities, or from the use of, or connection with any property or facilities provided, operated or controlled by them, or any, or either of them, and whether arising while engaged in racing or qualifying, or in practice or preparation for said races or activities, or while upon said premises or at all, and the undersigned assumes all risks of injury or damages to the person or property, or death of the undersigned while upon said premises, whether caused by negligence or otherwise, or however caused, and the undersigned agrees that no other agreement or contact, whether verbal or written shall in any manner affect this release. This is intended to be a complete and full release, waiver and relinquishment, given up, foregoing and discharging of all claims or damages of every kind, character and description against said parties, or either, or any of them, that may have happened in the past or that may happen in the future, more particularly during the calendar year by which the undersigned does hereby agree to hold said parties free and clear from all loss and liability of any kind or character by reason of any act or conduct of UMARA, a corporation, its officers, officials, representatives or employees, owners or any other person, during said race or races, or any practice or qualifying thereof, or any event that may be held thereon, and that the undersigned assumes all risk for injury or damages to the person or property of the undersigned caused by any defect in the speedway or property upon which the race is held, or the equipment or operation of the equipment thereon including signal or signaling flags and the undersigned assumes all liability for any injury or damages sustained by the undersigned through any negligence, or otherwise, of the said parties. This instrument is signed voluntarily by the undersigned and the undersigned will hold the said parties and each of them free and clear from all responsibility by reason of the undersigned while upon said premises, participating, practicing or qualifying in any event on said speedways, and will hold said parties and each of them harmless from any court cost, attorney's fees, or any other expense whatsoever caused by any suit for injury or damages brought by the undersigned, or anyone for his, or on his behalf, or by his executors or administrators, in connection with any suit, or otherwise, and the undersigned does hereby certify that he will examine the speedway, and will examine the property of the speedway, and grounds adjacent thereto, and the equipment erected thereon, and that his participation in any program will therefore automatically indicate and affirm his acceptance of the same as satisfactory, and while the undersigned understands that there is certain safety equipment on the track, still he acknowledges that he does not depend upon said equipment but upon his own judgment or ability while upon said premises. The plural includes the singular and the singular includes the plural herein, and the pronoun "them" and the word "parties" used herein include the corporation, firm or individuals as well as all others mentioned herein. The venue for any litigation that relates to any subject covered under this waiver shall, at the option of UMARA be Grundy County, Illinois.
